MSU Extension has created a new way for operators to view their water CEU hours. This new method has been designed to be easier to access on any computer, more reliable for operators, and can now be used on your phone/mobile device.

In order to use this new method, you must have an email address listed in our database. The issue we've seen is that operators either do not have an email address listed, the email address is old and they no longer use it, or their email address is misspelled in the database. These issues cause operators to be unable to use this new method, since you will use the email address listed in the database to "log in" and to receive your CEU record. No email address = no CEU login.

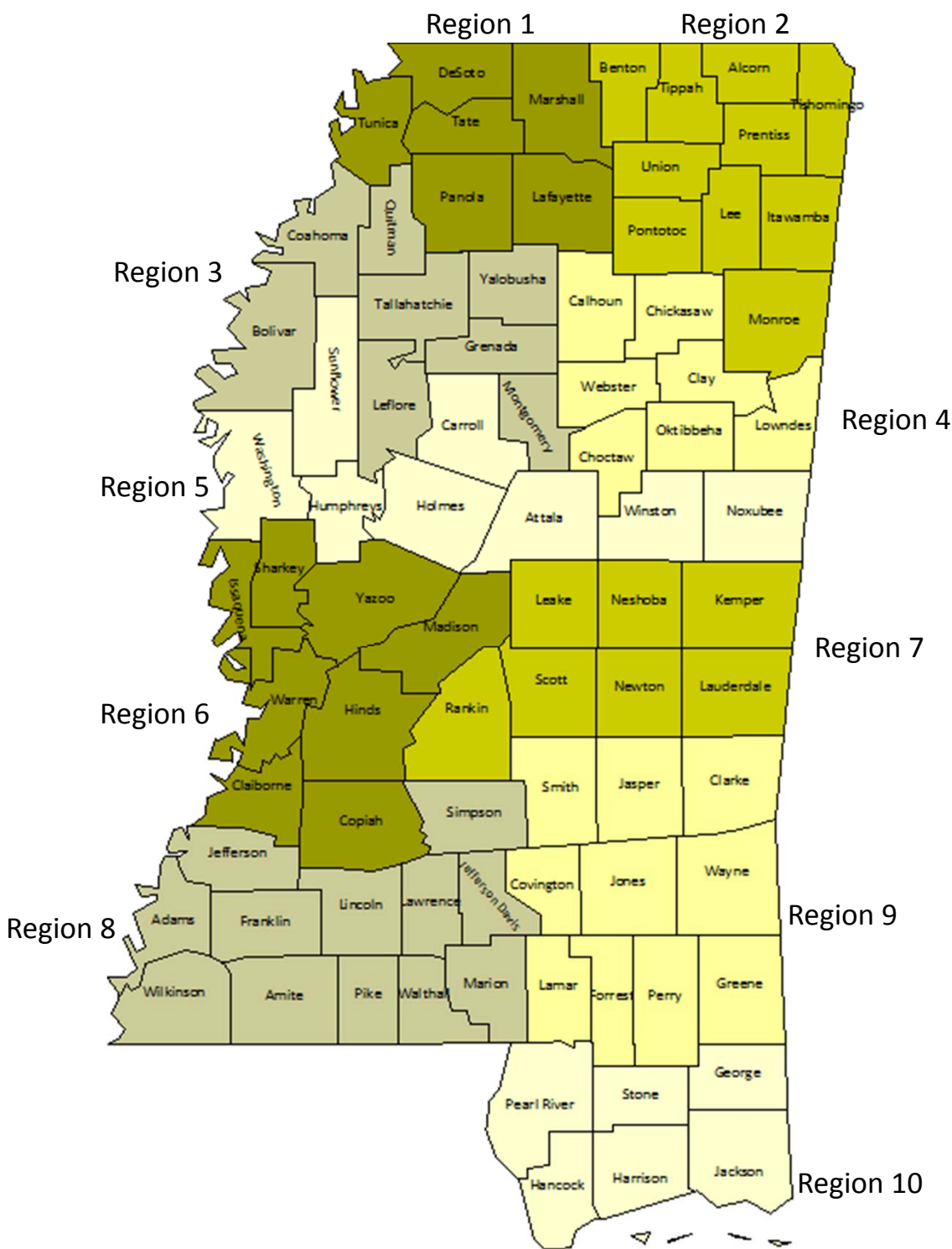
