Also, remember to please contact the training agency to make sure the training will be held. The information contained in this document was gathered from the MSDH-BPWS Training Calendar, so we have no information about if a particular training may be cancelled due to unforeseen circumstances.

We are entering tornado season here in Mississippi, with our first taste of severe weather affecting north Mississippi this past week. The following article on generator maintenance comes from a generator supplier, and contains important pointers to consider *before* severe weather hits your area.

Diesel generator sets – used for either prime or backup (emergency) power – must be regularly maintained to ensure they provide quality power throughout their service life. The life-cycle of power generators is well established and documented making routine maintenance fairly straightforward. Best generator maintenance practice is following the maintenance schedule provided by the manufacturer of the generator. A routine maintenance practice is that of general inspection. Inspections consist of checking for leaks, assessing oil and coolant levels, glancing at the belts and hoses and checking the battery terminals and cables. It is important to inspect the oil as well, as it must be changed regularly. Oil change frequency depends on the manufacturer, how often the generator is used and your work environment. Typically, it is recommended you change the oil after 100 hours of operation, especially if the generator uses diesel.

The long outstanding use of generators over time has provided the necessary knowledge to predict when certain components will fail or be in need of service. A fairly reliable maintenance schedule can usually be acquired from the manufacturer. Adhering to this schedule will ensure maximum service time for the generator and proper operation when it is called upon to provide power.

#### **Generator maintenance requires:**

- Annual fuel cleaning and filtering, as diesel fuel degrades quickly. After a few weeks of
  operation, diesel fuel degrades via contamination of water and microbes, resulting in
  clogged fuel lines and filters. Fuel cleaning involves using biocides annually in all generators
  except for the standby generator, in which it will attract moisture.
- The cooling system to be maintained, which requires checking the coolant level at existing intervals. This must be done during shutdown periods.

- Checking for battery power; this is especially true for standby generators, as battery issues are their primary cause of failure. Make sure the batteries are robust and charged enough to last long so as to not incur any start-up hitches for the generator.
- Regular testing to inform of the battery's current status. Testing involves checking the electrolyte levels and specific gravity of the batteries. The batteries themselves also must be clean.

Small investments made in replacing components and maintaining generators on a regular basis can save expensive and unnecessary upgrades or even replacement of the entire generator in the future.

When performing routine maintenance, each action taken should be logged, and the readings and various parameters are recorded along with the date of inspection and hour meter reading of the generator. These set of readings are compared with the next set of data collected. Any absurd variation of readings indicates faulty performance of the unit.


Load testing of automatic transfer switches in regular intervals keeps track of the component's electrical and mechanical integrity in the actual mechanical transfer operation. Other factors to be checked periodically are starting and timing relays, start signal continuity, and utility phase sensing.

Preventative maintenance thus ensures that you get uninterrupted power supply for all your needs.
