EMPLOYMENT AND INCOME IMPACTS
Forest-related economic activity in Wayne
County during 2013 generated 1,031 jobs and
more than \$43.9 million in income. That's about
13.4% of jobs and 13.8% of income in the
county. Employment is the number of full- and
part-time jobs in all sectors of the economy.
Income is salaries and wages paid to employees.

#### TOTAL OUTPUT AND VALUE ADDED IMPACTS

Forestry and the forest products industry generated more than \$147.5 million, or about 13.4% of economic output, in Wayne County. Forest-related value added amounted to more than \$55.9 million, or about 11.2% of all value added in the county. The value of all goods and services produced is defined as total output. Value added is a portion of total output and represents the creation of new wealth.

#### TAX IMPACTS

Forest-related economic activity contributed an estimated \$13.3 million in tax revenue for federal, state, and local governments. This total includes tax revenue of \$8.3 million for federal and \$5 million for state and local governments.
