This is a reminder that the Mississippi State University Extension Service is offering the **FREE** Peer Review Program to public water systems throughout Mississippi. This program is designed to provide technical, managerial, and financial assistance to strengthen the operations of public water systems. Experienced volunteer water operators perform the Peer Review session and suggest ways to improve the deficiencies of water systems or offer their assistance. The results are kept confidential; no regulatory agency knows about your participation in this program.

Our program provides an opportunity for water systems to increase scores on the Mississippi State Department of Health Capacity Assessment. This program is best suited for systems with lower scores on the Capacity Assessment inspection, but can be a benefit to any system with room to improve. This is also a great program for water systems with new personnel, mayors, clerks, board members, etc. to familiarize themselves with the water system and ways to improve the system with little to no risk.

A Peer Review session is typically a one-time meeting between water system personnel/officials and our volunteer operators lasting about 2 hours. Following the session, you are provided with a report summarizing all the information discussed during the Peer Review.


