## Examples include:

- Amputation
- Arthritis
- Back Injury
- Chronic Pain
- Head Injury
- Health Conditions
- Hearing Impairment
- Heart Conditions
- Respiratory Diseases
- Spinal Cord Injury
- Visual Impairment

Farmers with disabilities can utilize various types of assistive technology to aid their work. This technology can be purchased or safely constructed with the guidance of AgrAbility engineers and assistive technology specialists.

- Adaptive hand and machinery tools for a variety of tasks.
- Wheelchairs and utility vehicles for outdoor mobility.
