# Kemper County

#### **EMPLOYMENT AND INCOME IMPACTS**

Forest-related economic activity in Kemper County during 2013 generated 671 jobs and more than \$30.7 million in income. That's about 10.4% of jobs and 8.5% of income in the county. Employment is the number of full- and part-time jobs in all sectors of the economy. Income is salaries and wages paid to employees.

#### TOTAL OUTPUT AND VALUE ADDED IMPACTS

Forestry and the forest products industry generated more than \$80 million of economic output in Kemper County. Forest-related value added amounted to more than \$36 million. The value of all goods and services produced is defined as total output. Value added is a portion of total output and represents the creation of new wealth.

#### TAX IMPACTS

Forest-related economic activity contributed an estimated \$7.7 million in tax revenue for federal, state, and local governments. This total includes tax revenue of \$5 million for federal and \$2.7 million for state and local governments.

Forestry and forest products are important to Kemper County's economy. They contribute to many sectors of the economy. The economic contribution of forest-related sectors and their impacts on other sectors can be estimated using input-output analysis. Using 2013 data, this study estimates the total economic contribution of forestry and the forest products industry to Kemper County, Mississippi.
