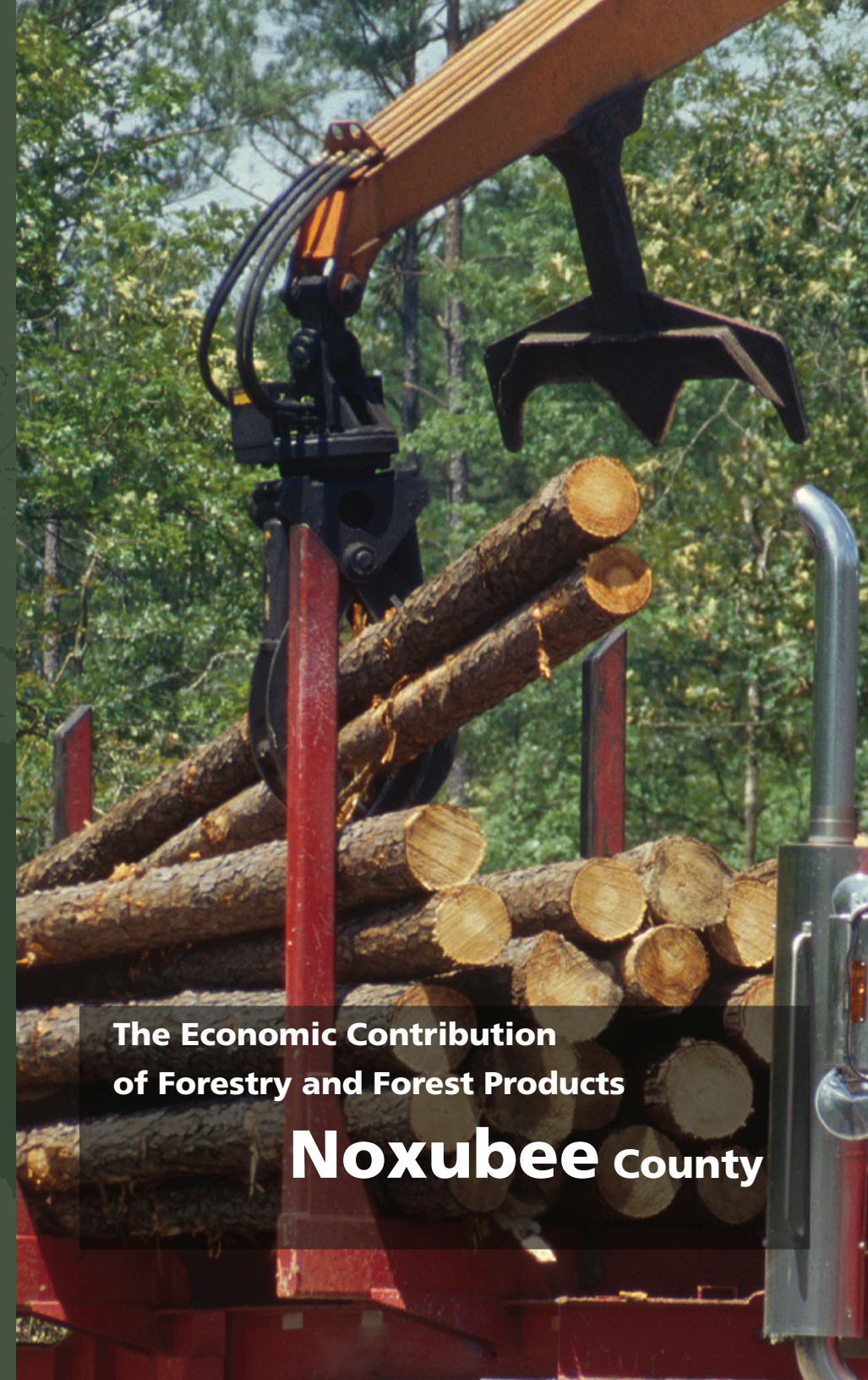

EMPLOYMENT AND INCOME IMPACTS

Forest-related economic activity generated 728 jobs and over \$26 million in income in Noxubee County during 2007. That's about 15.9% of jobs and 20.9% of income in the county. Employment is the number of full- and part-time jobs in all sectors of the economy. Income is salaries and wages paid to employees.

TOTAL OUTPUT AND VALUE ADDED IMPACTS

Noxubee County's forestry and the forest products industry generated over \$143.9 million, or about 26.7% of total economic output. Forest-related value added amounted to over \$55.5 million, or about 25.5% of all value added in the county. Total output is the value of all goods and services produced. Value added represents the creation of new wealth.

TAX IMPACTS

Forest-related economic activity contributed an estimated \$10.9 million in tax revenue for federal, state, and local governments. This total includes an estimated tax revenue of \$6.6 million for federal and \$4.3 million for state and local governments.
