







To calculate the index, each succeeding year's veteran population was divided by the 2011 veteran population. An index value above 1.0 indicates that the veteran population is growing; an index below 1.0 indicates that the veteran population is declining. Data were obtained from the National Center for Veterans Analysis and Statistics, U.S. Department of Veterans Affairs.



Categories included in Total Expenditures include *Compensation and Pension; Education and Vocational Rehabilitation and Employment; Insurance and Indemnities; Construction and Related Costs; General Operating Expenses; Loan Guaranty;* and *Medical Expenditures*. 


